The following is to help you with the most frequently asked questions and explanation of terminology.

Accredited course This term explains the program is not a standard variant of an existing training package. It is a customized program that is accredited by the regulator ASQA as a national qualification.

Authorisation This is required of any participant who wishes to enroll into a qualification program or seminar offered by Nelson Education. It is your statement of commitment to the program and the fees due.

Campus Nelson Education offers its programs and seminars in centrally located facilities. Often in the CBD in training rooms, board rooms or hotel meeting rooms.

Delivery **Executive Delivery** is scheduled monthly in each capital city of Australia.

Customised Delivery can be arranged for clients with onsite delivery.

Enrolment Deposit Please note Qualification programs require an Enrolment Deposit of \$1500 should accompany your application. This is a nonrefundable amount. When your enrolment is processed you will be invoiced for the first seminar. There will be a total of eleven invoices. One prior to each seminar. Please note should your invoice not be finalised by the due date you will not be authorised to attend the corresponding seminar. Payment plans & direct debit may be arranged if required.

Payment Plans

Proof of ID Nelson Education and its affiliate AssentTECS needs to report your progress and results at any Audit by the regulator. We also may be subject to audits from the state and federal government and may need to evidence your existence as a legitimate person who has enrolled. This is particularly critical to any funded participants.

Qualifications Refund Policy **You must read and understand the refund Policy for Qualifications.** Given the holistic nature of delivery the units are delivered in a non-linear fashion. This results in participants partaking learning from a number of units at once. As a result there is no refund offered once the course is commenced. Should you experience compassionate or compelling circumstances you may apply for consideration.

AssentTECS Refund Policy

It is the policy of AssentTECS to ensure that all applications for refund of fees are considered.

An initial non-refundable enrolment fee will apply to all courses. A course deposit is also required payable two weeks (10 working days) prior to the commencement of the course. No refund applies to the enrolment fee should the applicant not enrol in the training program.

- A full refund of fees is available up to 10 working days prior to the commencement of the training program. Cancellation of enrolment under these circumstances does not incur a penalty. However, the administration fee is non-refundable. Refund of the merchant fee may be applicable.
- Where cancellation is made less than 10 working days prior to the commencement of a course, the applicant will be eligible for eighty percent (80%) refund on enrolment fees. However, participants will be provided with an option to transfer to a course being offered at an alternate time.
- Where cancellation occurs up to 5 business days prior to the commencement of a training program, no refund applies. However, participants will be provided with an option to transfer to a course being offered at an alternate time.

Once training has commenced in the course, no refund is available to participants who leave before the completion of the course unless the participant can provide a medical certificate or show extreme personal hardship.

Refunds will be considered on a pro-rata basis for students who fall ill or are injured to the extent that they can no longer undertake the course providing a supporting Medical Certificate is supplied to AssentTECS. However, should participants wish to finalise incomplete units of competency in a future course, the original fee can be used as a credit towards that course. This offer is available within a 12 month period from the time the initial payment is made.

Should the RTO cancel a course, participants are entitled to a full refund (or pro-rata adjusted refund) or transfer of funds to another/future course. In this event, participants will be given their preferred option.

In all other cases, refunds are at the discretion of the CEO, AssentTECS and may be negotiated on an individual case-by-case basis.
